OASIS PROVIDES PERMANENT SANCTUARY AND LOVING CARE FOR EXOTIC BIRDS, MAINLY PARROT SPECIES, FOR WHOM OTHER HOME /CARE OPTIONS DO NOT EXIST. SOME ARRIVE AS ABUSE OR NEGLECT CASES, TRAFFICKED BIRDS OR RESCUES BY LOCAL AND FEDERAL GOVERNMENT AGENCIES. MANY ARE AGING OR HAVE SPECIAL NEEDS. IN EARLY 2020 OASIS OPENED A 5000 SQFT INDOOR/OUTDOOR AVIARY BUILDING TO PROVIDE A HOME FOR UP TO 75 PARROTS, PARTICULARLY GERIATRIC AND SPECIAL NEEDS PARROTS. THESE BIRDS ARE NOW ABLE TO ENJOY A MORE SPACIOUS FLOCK ENVIRONMENT WITH SECURE OUTDOOR ACCESS FOR FRESH AIR AND SUNSHINE. THIS ADDITIONAL SPACE GAVE US THE OPPORTUNITY TO ASSIST 44 NEW ARRIVALS TO SETTLE INTO SANCTUARY LIFE AMONG THEIR OWN KIND, WITHOUT HUMAN PRESSURES. CONSIDERING NATURAL ATTRITION OF OUR FLOCK, WE MANAGE AND CARE FOR 800 PARROTS-FROM BUDGIES TO MACAWS. DUE TO THE UNUSUALLY LONG LIFE SPAN OF PARROTS, OUR MISSION WILL NEED TO SUSTAIN FOR MANY YEARS TO COME.

WE OFFER NATURALISTIC AVIARY HABITATS WHENEVER POSSIBLE, TO PROVIDE OPPORTUNITIES FOR FLIGHT, AND FLOCK ENRICHMENT AND SUPPORT. OTHER SUITABLE ENVIRONMENTS ARE OFFERED FOR SPECIAL NEEDS BIRDS. AVIARY INFRASTRUCTURE CONTINUES TO BE IMPROVED FOR SAFETY, COMFORT AND SUSTAINABILITY OF ALL RESIDENTS. OASIS PROVIDES EDUCATIONAL OPPORTUNITIES FOR THE PUBLIC ON NEEDS AND PROPER CARE OF PARROTS, THE CRITICAL OVERPOPULATION OF PET PARROTS AND THE URGENT NEED FOR CONSERVATION OF PARROTS IN THE WILD. WE TYPICALLY PROVIDE EDUCATION THROUGH PRINT AND ONLINE PUBLICATIONS, SPEAKING ENGAGEMENTS AND EDUCATIONAL TOURS OF THE FACILITY. 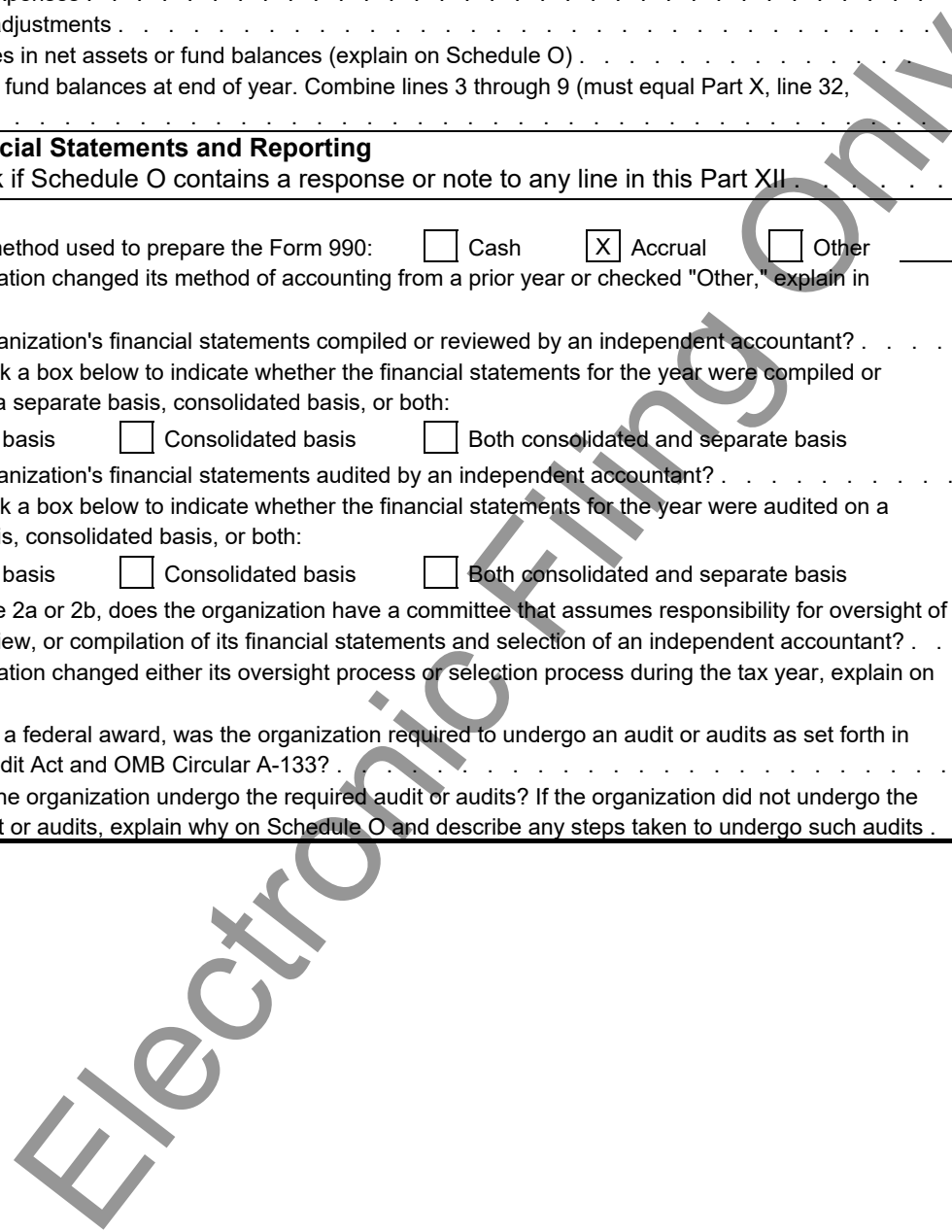
